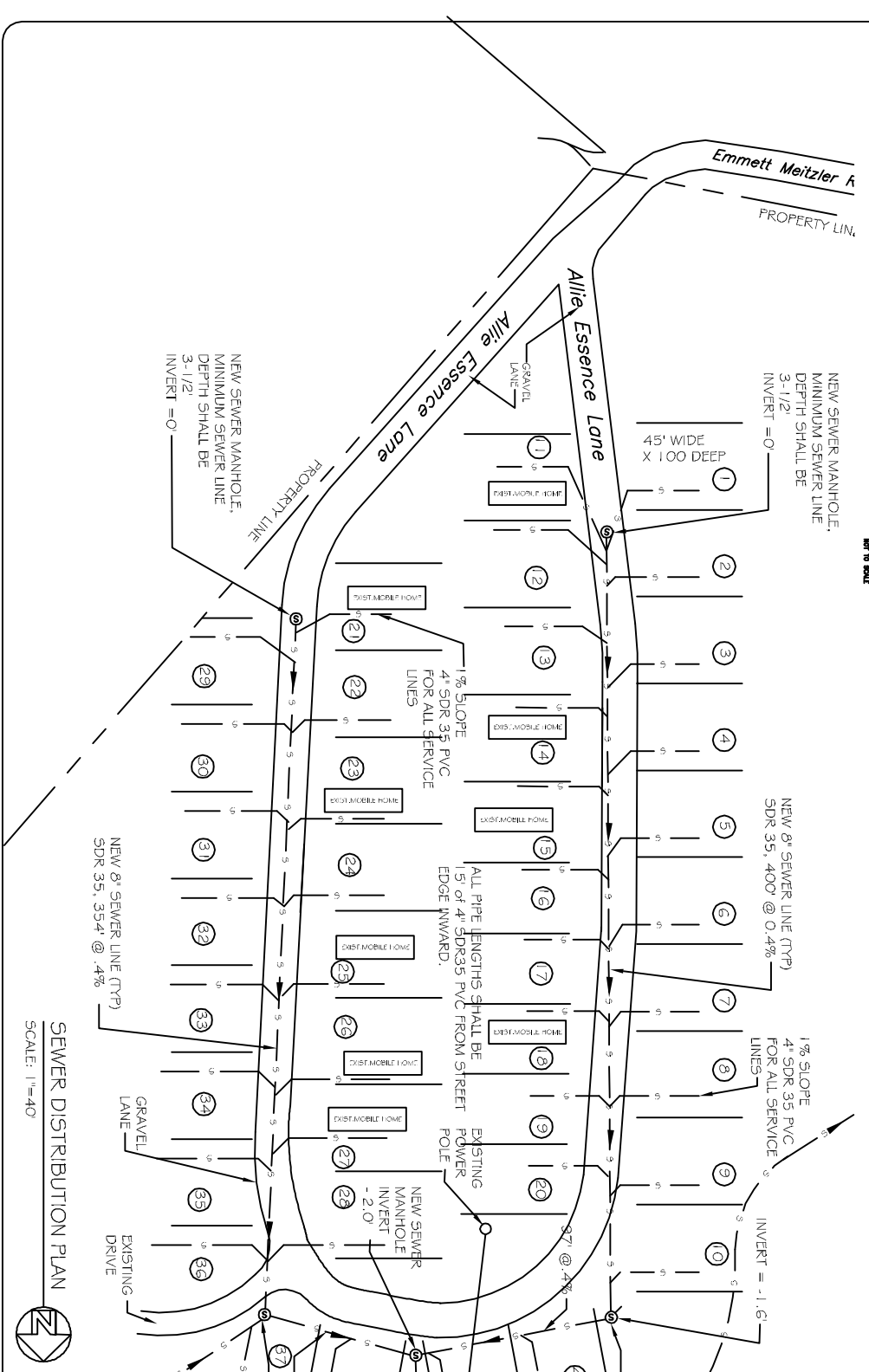
GENERAL NOTES:

2. ALL WORK AND MATERIAL SHALL CONFORM STRICTLY TO THE LATEST LOCAL, CITY, COUNTY, STATE AND NATIONAL GOVERNING CODES.
3. CONTRACTOR IS TO FIELD VERIFY ALL EXISTING UTILITY LOCATIONS, ELEVATIONS AND SIZES PRIOR TO COMMENCING ANY WORK. CONTRACTOR SHALL PAY NECESSARY FEES FOR THE UTILITIES CONNECTIONS.

7. ALL FLOWING SHALL BE CLOSELY COORDINATED WITH WATER SYSTEM.
8. ALL SEWER LINES SHOWN ARE DIAGRAMATIC.
9. ALL SEWER LINES SHALL BE SLOPED 1/8" PER FOOT.
10. MINIMUM PIPE BURIAL SHALL BE 3'-0"
