Note: The PRELIMINARY DFIRM on the LSUagcenter website shows the front 13 feet more or less of the lot in zone AE, EI. 11 NAVD88. The rear 62 feet more or less of the lot is shown in zone VE, EI. 14 NAVD88. The ABFE map show the property in zone AE, EI. 13 NAVD88. I used 14 in the VE zone on line C2.c) to use the higher of the 3. BEFORE house plans or construction, check with the local governing body to see which zone and BFE they are going to enforce because the parish hasn't officially adopted the preliminary DFIRM of ABFE. (zone VE BFE is to the lowest horizontal member)
