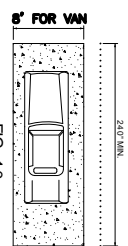

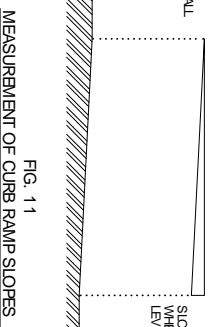

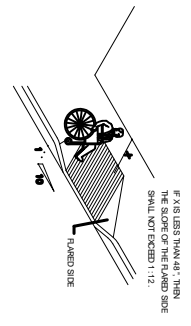

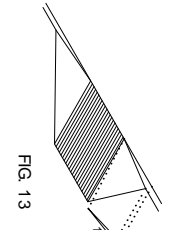

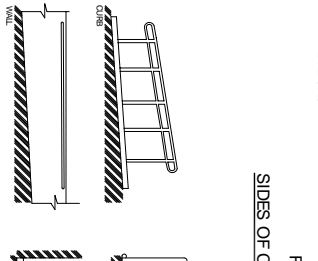

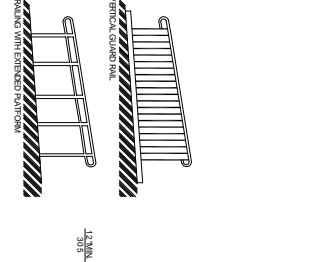

EXAMPLES OF EDGE PROTECTION AND HANDRAIL EXTENSIONS

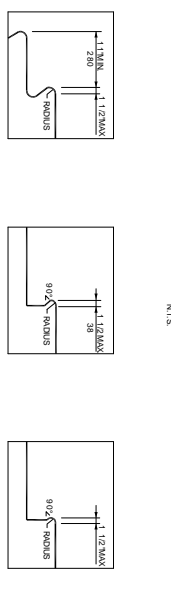

USEABLE TREAD WIDTH AND EXAMPLES OF ACCEPTABLE NOSINGS

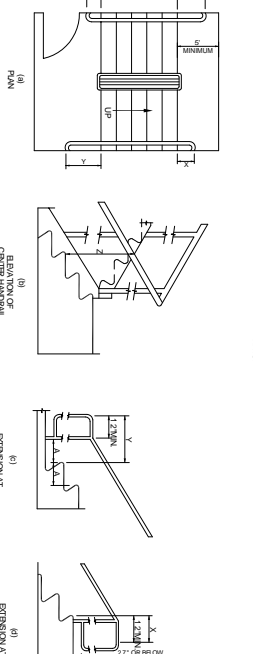

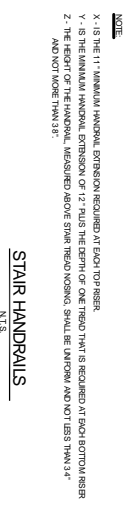

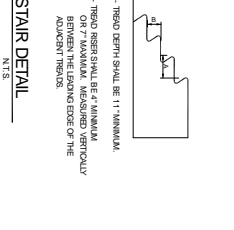

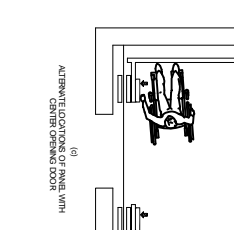

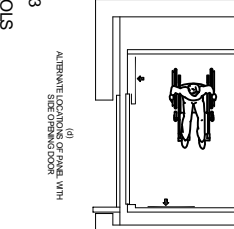
