- The applicant shall not begin work until the permit application is approved and signed by the appropriate City official.** Failure could result in penalty.
- All electrical work shall comply with the 1996 National Electric Code, with one exception: The use of aluminum wire and electrical wire smaller than 12 shall not be permitted on the service (use) side of the building meter for any voltage of 115 volts or more.
- All work governed by the NEC, including connections and repairs to sign, exterior lighting, underground and overhead cables shall be done by electrical contractors registered within the City of Hammond.
- This permit becomes null and void if work or construction authorized is not commenced within 6 months, or if construction or work is suspended or abandoned for a period of 6 months at any time after work is commenced.
- I hereby certify that I have read and examined this application and know the same to be true and correct. All provisions of law and ordinances governing this type of work will be complied with whether specified herein or not. The granting of a permit does not presume to give authority to violate or cancel the provision of any other state or local law regulating construction or the performance of construction.
