

 I show 11 on line C2.a) because St. Tammany Parish requires the minimum finished floor elevation in this area to match the ABFE determined by FEMA. Zone AE 11, ABFE 11, Panel MM39, Date Jan. 18, 2006.
 Verify prior to construction with local governing body. My client intends to build garage lower than BFE 11 so will require venting to equal or exceed the square footage of the garage.
