1. DIMENSIONS ON PLANS ARE TO FACE OF STUD TYP, UNLESS NOTED OTHERWISE. STUDS NOT DIMENSIONED ARE 2 x 4 TYPICAL (3 1/2") DEEP UNLESS NOTED OTHERWISE.

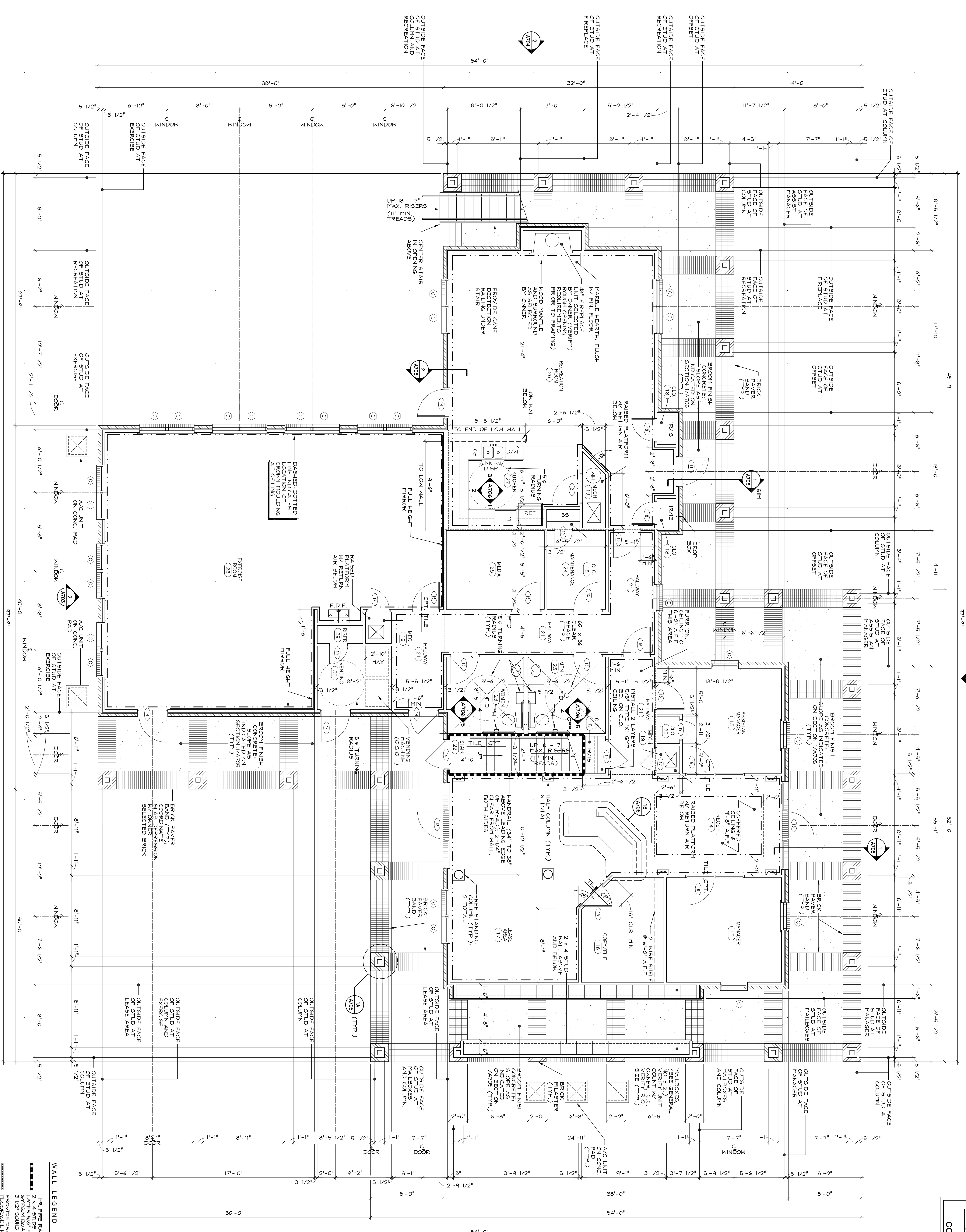
2. CONTRACTOR TO VERIFY CLEARANCES REQUIRED FOR THOSE INDICATED AND NOTIFY OWNER OR ARCHITECT OF ANY DISCREPANCIES.
3. PROVIDE INTERNATIONAL SYMBOL OF ACCESSIBILITY SIGNAGE AT RESTROOM DOORS AND OTHER PUBLIC AREAS. THE SIGNAGE SHALL RAISED LETTERS AND BRAILLE MOUNTED AT LATCH SIDE OF DOORS 60" A.F.F., STYLE BY OWNER.
4. MAXIMUM SHALL BE MOUNTED 48" MAX. A.F.F. TO HIGHEST LOCKSET. (SEE DRAWING IN A.F.F. TO LATCH)
5. PROVIDE ONE (2) PORTABLE FIRE EXTINGUISHERS IN ACCORDANCE WITH NFPA SECTION 906 (NFPA 10). LOCATE EXTINGUISHERS IN THE FIRE ALARM PANEL POINT OUT OF REACH OF EXTINGUISHER 48" MAX. A.F.F.
6. ROUTE 2" MIN. WIDE ACCESSIBLE ROUTE WITHIN EXISTING ROOM 20 AROUND EQUIPMENT.
7. PROVIDE LEVER STYLE HARDWARE AT ALL PUBLIC AND COMMON USE RESTROOMS AND EXISTING ROOM DOORS.
8. FLUSH VALVE AT TOILETS SHALL BE INSTALLED ON THE SIDE OF THE TOILET OPPOSITE THE FRONT THE SIDE WALL.
9. PROVIDE HORIZONTAL LOWER BLINDS FOR EXISTING TOILET ROOM DOORS AND FLYED ENTRY TO DOOR UNITS.
10. INTERIOR WALLS AND CEILINGS SHALL HAVE A FLAME SPREAD OF 0-200, EXCEPT IN CORRIDORS WHICH SHALL HAVE A FLAME SPREAD OF 0-75 AND A SMOKE DEVELOPMENT RATING OF 0-450.
