Minutes:

- Meeting opened with signing in of attendees - see attached sign in sheet.

- The following information was disseminated during the construction meeting:
 1. The pavers on the North West side of the property were discussed to verify that it meet the needs of Mike Noto. The garden spot verified the sizes that he can get and the overall layout will be 19'6"x130'. The pavers will start at the street and will end 130' out from there.
 2. The sprinkler system is a Rain Bird and will have a five year warranty provided by the landscaping contractor.
 3. A, 2" water meter will be provided by Mike Noto.
 4. Concerns and questions were addressed about the overall width if the sidewalk design for the Court Yard and it was decided to remain as is with the exception of removing some pavers that were duplicated alongside the existing pavers.
 5. During excavation for the parking lot an old grease trap was found and removed.
 6. The Garden Spot will start to install the big trees next to bldg #1 as not to crossover the new sidewalks that will be installed.
 7. The pond was discussed in length as to the overall design. The footings will be eliminated and added back into the thickness of the foundation. The water level shall change from 18" to 12" deep. There was another conceptual pond presented for approval using the overall layout except in the rear corner it shall be squared off to allow a (wall) waterfall type atmosphere that will hold 4 logs to be installed on it. The City Of Slidell will provide the names and logo to be placed on the wall for a template; this will allow New Orleans pool & patio to prepare prices for approval.
