**NOTES:**

1. DECKING SHALL BE INSTALLED IN ACCORDANCE WITH LOUISIANA STATE SANITARY CODE, PART XXIV, 323 F.3, G & Q.
2. PRESSURE OR VACUUM GAUGE SHALL BE INSTALLED IN ACCORDANCE WITH LOUISIANA STATE SANITARY CODE, PART XXIV, 503 C-1.
3. ALL DRAIN INLETS SHALL DISCHARGE 1'0" TO 1'5" BELOW THE SURFACE OF THE WATER IN ACCORDANCE WITH LOUISIANA STATE SANITARY CODE, PART XXIV, 511 B-1.
4. DEPTH MARKERS SHALL BE PLACED IN ACCORDANCE WITH LOUISIANA STATE SANITARY CODE, PART XXIV, 701 A, 1-4 AND 9. IN ADDITION TO THE MARKINGS SHOWN, ADDITIONAL MARKERS SHALL BE LEGIBLE FROM INSIDE THE POOL.
5. THERE WILL BE NO PHYSICAL CONNECTION BETWEEN THE POOL OR POOL PUMP AND THE POTABLE WATER SYSTEM IN ACCORDANCE WITH LOUISIANA STATE SANITARY CODE, PART XXIV, 707 A AND 709 B.
6. THERE WILL BE NO PHYSICAL CONNECTION BETWEEN THE POOL DRAINAGE SYSTEM AND BACKWASH FILTER SYSTEM WITH THE LOCAL SEWER AND DRAINAGE SYSTEMS IN ACCORDANCE WITH LOUISIANA STATE SANITARY CODE, PART XXIV, 511 D.
7. THE DISINFECTANT FACILITY SHALL BE INSTALLED IN ACCORDANCE WITH THE LOUISIANA STATE SANITARY CODE, PART XXIV, 901 A, AND 903 A.
8. POOL FILLING SHALL BE ACCOMPLISHED MANUALLY WITH A GARDEN HOSE. DURING FILLING OPERATIONS, THE HOSE SHALL NOT BE SUBMERGED TO PREVENT CROSS CONNECTIONS IN ACCORDANCE WITH LOUISIANA STATE SANITARY CODE.
