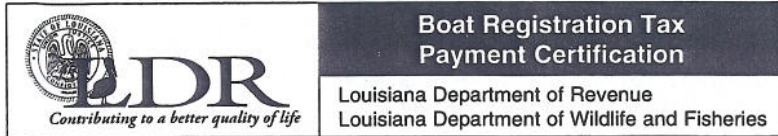

NOTICE TO BOAT OPERATORS

1. This certificate must be aboard vessel when in use.
2. One U.S. Coast Guard approved personal flotation device for each person aboard vessel is required. Boats 16' and over, see regulations.
3. Number assigned to vessel must be firmly attached to hull - per regulations.
4. Should ownership or address change or vessel be abandoned, owner must notify the Department of Wildlife, Fisheries and Parks within 15 days.
5. Stop to render aid if involved in a boating accident. Report all accidents to the Department of Wildlife, Fisheries and Parks involving injury, death or property damage in excess of \$100.
