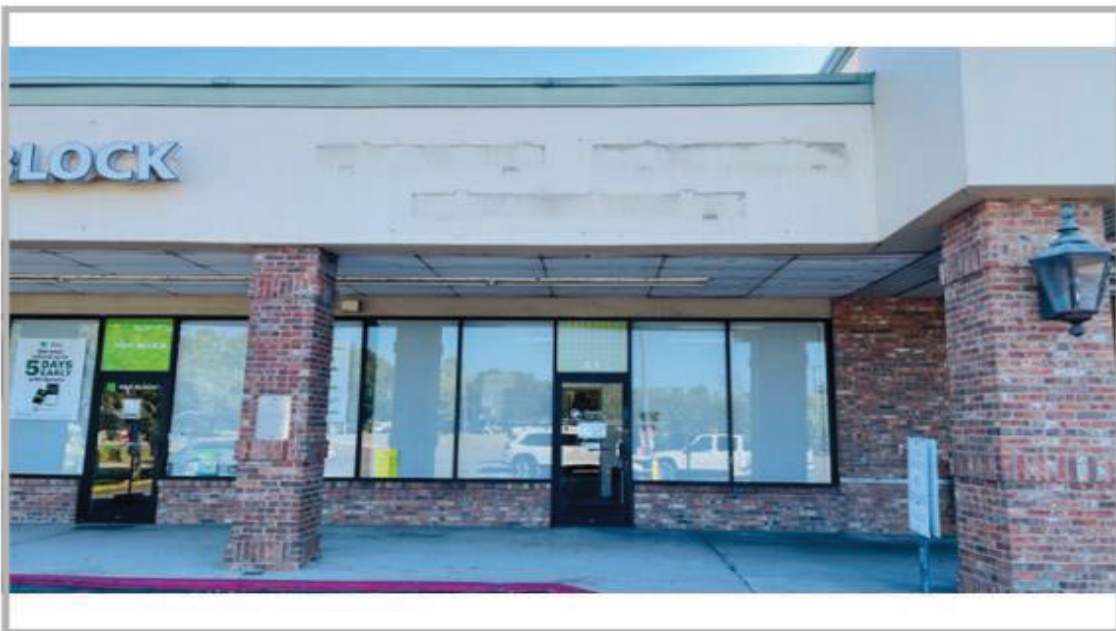

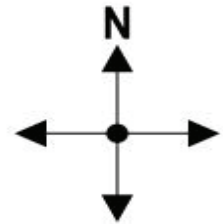
SITE PLAN

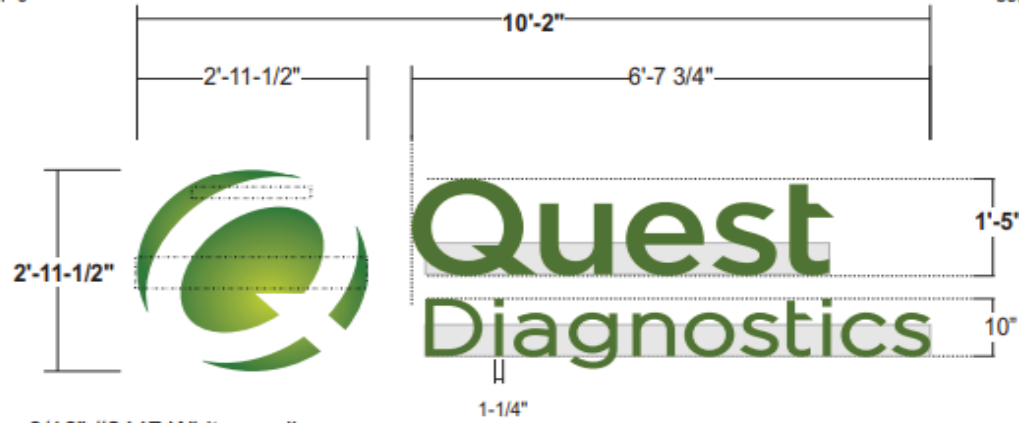

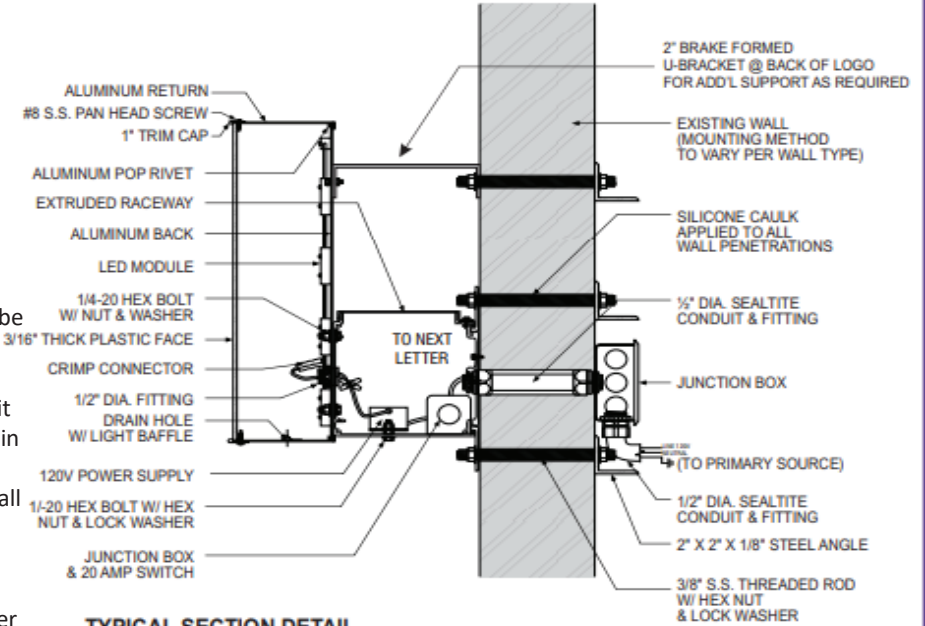

Letters to have surface applied green vinyl
Logo to have surface applied digital print
- TRIMCAP:** 1" green trimcap
- RETURNS:** 5" deep .040 aluminum coil; pre-coat factory finished to match brushed aluminum
- BACKS:** .063 alum. backs - insides painted White
- ILLUM.:** White Bitro Bantam LED's as required by manufacturer;
Power supplies housed within raceway
- RACEWAY:** 5.5" x 5.375 Extruded alum. raceway or equiv. painted to match sign band;
Additional bracing as required behind logo
- WALL MATERIAL:** Signband wall material is EFIS Over PLYWOOD, METAL STUDS
- INSTALL:** Backer framing thru bolted using all thread into blocking as required
12" standard length of threaded rod will be supplied unless otherwise noted
3/8" threaded rod into blocking or Stratus approved equivalent
Compression sleeves required to avoid crushing wall & achieve max tensioning

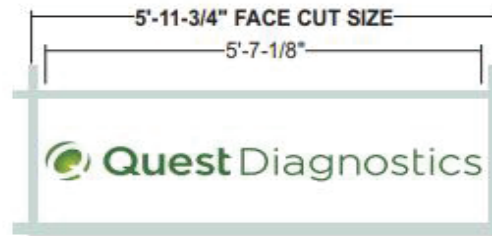

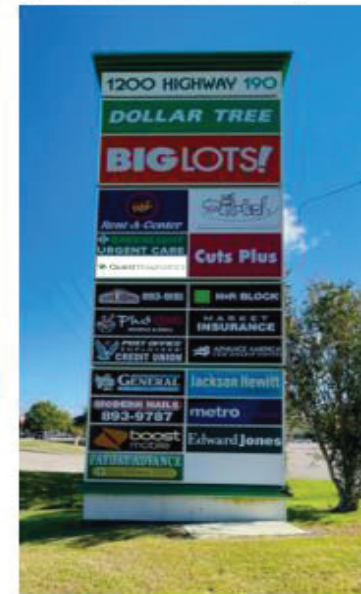
