KNOW ALL MEN BY THESE PRESENTS, that the undersigned, person capable of contracting, availing myself of the benefits and provisions of the Constitution and Laws of the State of Louisiana, and particularly Louisiana Revised Statute Title 12 Chapter 22 (LA R.S. 12:1301, et seq.) do hereby organize and constitute a Limited Liability Company in accordance with the following articles, to-wit:

**ARTICLE 1
NAME OF COMPANY**

**ARTICLE 2
DURATION**

Unless dissolved earlier by law or agreement, the existence of the Company will be perpetual.

**ARTICLE 3
POWERS AND PURPOSE**

The objects and purposes for which this Company is organized and the nature of the business to be carried on by it are stated and declared to be as follows:

To enter into any business or activity lawful under the laws of the State of Louisiana, including but not limited to real estate development, either for its own account, or for the account of others as agent, and either as agent or principal to enter upon or engage in any kind of business or activity of any nature whatsoever in which companies organized under the Limited Liability Company Law of the State of Louisiana may engage; and to that extent not prohibited thereby to enter upon and engage in any kind of business or activity of any nature whatsoever in any state of the United States of America, any foreign nation, and any territory of any country to the extent permitted by the laws of such state, nation or territory; and to have and exercise all the other express, implied and incidental powers conferred by the laws of the State of Louisiana or by an other applicable governmental body or agency.



to do so to the other members. This notice shall be given by registered mail, stating the percentage interest owned by the member to be sold or donated, the price if the proposed transfer is a sale, the transferee and any other terms and conditions. If it is a proposed donation, the other members shall have the right to purchase the interest to be transferred at fair market value. If it is a sale, the right of purchase shall be under the same terms and conditions as offered by the third party transferee. The other members shall have thirty days from receipt of the notice to notify the transferring member of his/her intent to purchase the membership interest. Should there be two or more members desiring to purchase the membership interest offered for sale or donation, the membership interest shall be prorated among the members desiring to purchase said membership interest. Proration shall be based upon the proration of the membership interest existing between the members desiring to purchase immediately before the purchase of said membership interest. If the other members decline to purchase the membership interest, then and in that event only, the membership interest may be transferred in accordance with the original notice given.

ARTICLE 10
Amendments and Addendums

Amendments and Addendums to these articles of organization shall be made by unanimous vote of the members of the limited liability company.


