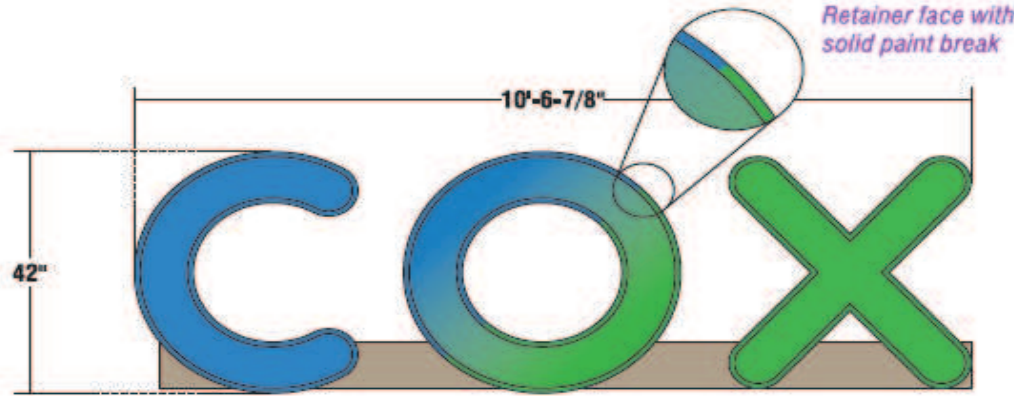

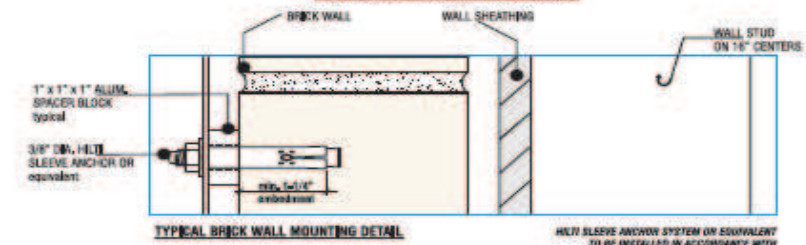
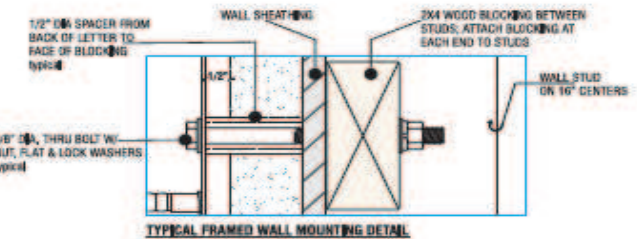


- FACES:** 3/16" #2447 White acrylic with surface applied, digitally printed vinyl graphics to match shown
- RETAINERS:** 1/2" Metal retainers faces painted satin finish colors to match color palette - "C" blue, "O" divided blue/green at gradient line, "X" green; All sides painted white
- RETURNS:** 3" deep .050 alum. - White coil stock
- BACKS:** .080 Alum. - Insides pre-painted White
- ILLUM. :** White LED'S as required by manufacturer; **power supplies housed within raceway**
- INSTALL:** Standard 8" x 8" fab'd extruded alum. raceway Thru bolted flush to sign band using min 3/8" all thread fasteners with wood blocking as required; Additional kick back bracing to be added to raceway due to size of letters; Bracing painted to match wall

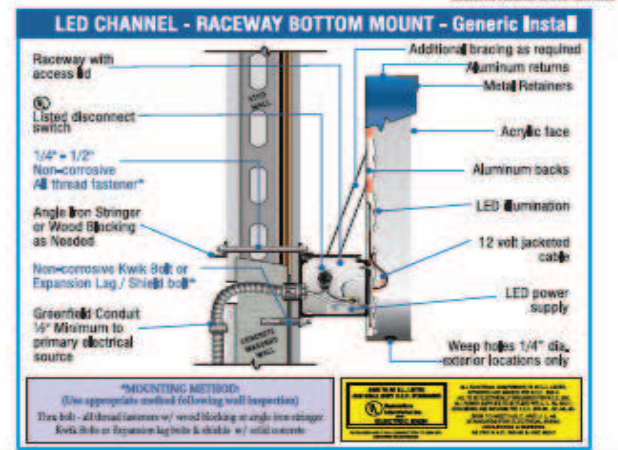
QUANTITY: (1) One channel letter sets required for front elevation.

- Electrical notes:
- All electrical components to be UL approved
 - Customer is responsible for one (1) 120v/ 20a dedicated circuit with ground per sign within 6' of sign.
 - Lockout switch installed at panel box for all electrical signs.
 - Install in accordance with N.E.C. Article 600 and/or local codes. This includes proper grounding and bonding of signs.

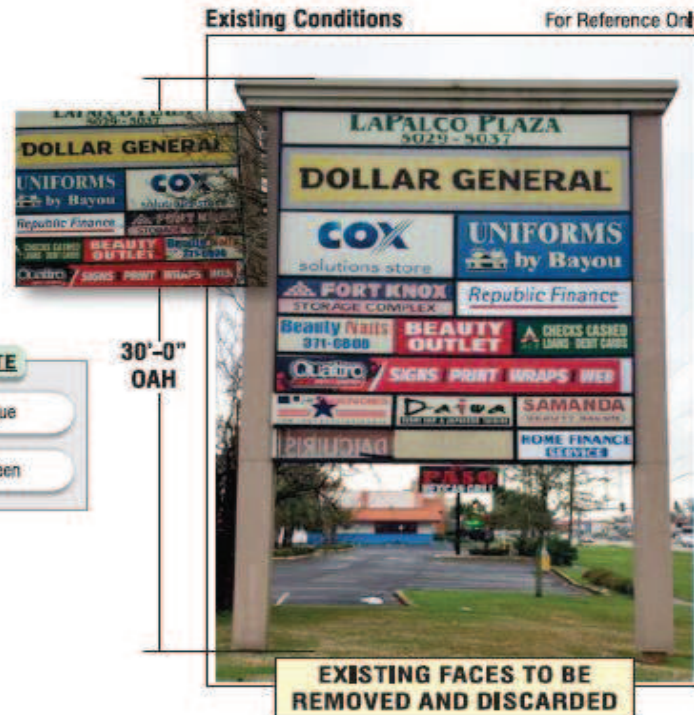
