1. Licensure requirements for both professional engineers and professional land surveyors include:

2. As a professional, your primary obligation is to:

True/False Questions:

21. True False A firm which has in its title the words “engineering” or “surveying” or any derivative thereof shall be construed to be offering to provide professional services and therefore must be licensed with the Board.
22. True False An unlicensed person practicing engineering or land surveying in Louisiana cannot have enforcement action taken against them by the Board.
23. True False Unless specifically exempt, it is unlawful for any person to practice or to offer to practice engineering or land surveying in Louisiana without being licensed by the Board.
24. True False When performing engineering work in Louisiana using a temporary permit to practice engineering, the licensee must use the seal from his/her jurisdiction of licensure, use his/her Louisiana temporary permit number and sign and date the work.
25. True False The Board has the authority to take disciplinary action against any licensee providing false testimony before the Board.
26. True False The term “licensee” shall mean any person practicing or offering to practice engineering or land surveying in Louisiana who has received a license from the Board and is otherwise in good standing with the Board.
27. True False Licensees may perform services only in the area of their competence.
28. True False A firm’s supervising professional must sign, date and seal all engineering and/or land surveying documents issued by the firm as completed work.
29. True False The Board allows the electronic transmission of documents containing seals and signatures.
30. True False Licensees are required to be familiar with and understand the Board’s rules of professional conduct.
31. True False Licensees may affix their signatures or seals to plans or documents dealing with subject matters in which they lack competence.
32. True False A licensee’s official seal must contain the following information: “state of Louisiana”; licensee’s name; license number; the words “Professional Engineer” or “Professional Engineer in _____ Engineering” or “Professional Land Surveyor”.
33. True False Preliminary documents do not have to be marked as such, but are required to be sealed.
34. True False Violations of the Board’s rules may result in the suspension of a licensee’s license to practice.

35. True False Professional engineers and professional land surveyors do not need to obtain an official seal upon licensure unless the work they intend to perform requires them to stamp plans, plats or other documents.
36. True False The requirement for continuing professional development is intended to protect the public by reinforcing the need for lifelong learning in order to stay more current with changing technology, equipment, procedures, processes, tools, and established standards.
37. True False Failure to comply with the continuing professional development requirements of the Board may subject licensees to disciplinary action by the Board.
38. True False The use of rubber seals and computer generated seals are both acceptable.
39. True False The Board has the authority to subpoena witnesses pertinent to any investigation authorized by the licensure law.
40. True False It is acceptable for a licensee to make slight exaggerations about his/her professional qualifications in advertising materials.

True False The responsibilities of a firm's supervising professional include: renewal of the firm's license and notification to the Board of any change in the firm's supervising professionals; institution and adherence of policies of the firm that are in accordance with the licensure law and the rules of the Board; and ensuring that all professional services provided by the firm are performed by or under the responsible charge of a licensed professional.
