## Fumigation Policy regarding Boats, Trucks, RVs, Cars, etc.

### Damage and Lost Item Release

Terminix will make every possible effort to avoid breakage or damage when tarping any property or vehicle. Occasionally certain items may become broken, as a result of working on the vehicle roof, or with placement and removal of tarps. Also, wind whipping the tarp can hook and pull on items resulting in breakage. These items include but are not limited to antennas, skylights, vent hatch covers, or anything protruding away from or above the vehicle. Some of these vehicles or property arrive at Terminix with minor damage, like cracking, and scratches but even the slightest movement can result in breakage or damage. Often the owner is unaware that such conditions exist. Plastic vents and skylights on certain vehicles are especially susceptible to becoming brittle. They can crack and/or break from just the weight or movement of the tarp.

I also understand that personal valuables, weapons, plastic storage bags and containers, and all food items are to be removed before a vehicle is delivered to Terminix. If not removed by the owner prior to delivery, Terminix will not be held responsible for the removal or any lost items.

I have read and understand the above statement and agree to hold Terminix harmless from any such damage or loss. It will be the owner's responsibility to make any and all necessary repairs at the owner's expense.
