**LOUISIANA STATE UNEMPLOYMENT INSURANCE

To avoid additional penalty and interest assessments all payments **MUST** be submitted on our website via EFT or ACH.

Missing wage and tax reports **MUST** be submitted electronically at www.laworks.net/lawatsemployer. Once missing reports are received online, a summary of the submission will be displayed by quarter including the contribution due with any applicable penalty and interest added. NOTE: Tax payment will be applied to the oldest quarter due.

NOTE: L.A.R.S. 23:1543(A) PROVIDES THAT:

If contributions are not paid on the date on which they are due and payable as prescribed by the administrator, the whole or part remaining unpaid thereafter shall bear interest at the rate of one percent per month from the due date until payment is received by the administrator and shall be further subject to a penalty on both the contributions and interest of five percent for each month or part of a month after the due date not to exceed an aggregate penalty amount of twenty-five percent. In computing interest for any period less than a full month, the rate shall be one-thirtieth of one percent for each day or part thereof.

NOTE: L.A.R.S. 23:1545 PROVIDES THAT:

If an employer fails to file a report or return required by the administrator for the determination of contributions, the administrator, or his duly authorized representative, may make such reports or returns or cause the same to be made, and determine the contributions payable on the basis of any information that he may be able to obtain, and shall collect the contributions so determined together with any interest and penalties due thereon under this chapter.
